This agreement is made and entered by and between Kelly / Warner, PLLC ("KWLaw") and Barri Grossman ("Grossman"), an individual.

RECITALS

WHEREAS, KWLaw endeavors to conduct itself with the utmost professionalism and tact.

WHEREAS, Grossman is an independent contractor for the firm that assists in maintaining KWLaw's websites and blogs, which includes the writing of content to be posted on the blogs.

WHEREAS, KWLaw has certain policies and procedures in place to ensure that conflict checks are performed before any content is posted on its blogs.

WHEREAS, Grossman was aware of these policies and procedures and understands they are crucial.

WHEREAS, regardless of being aware of these policies, Grossman failed to obtain permission before posting entitled, EXTORTION RACKET WEBSITES: MUGSHOT & SEX OFFENDER SITES, which KWLaw did not authorize.

WHEREAS, Grossman understands and acknowledges that Grossman shall be terminated should Grossman fail to obtain approval before posting any articles and/or should any false, defamatory, or infringing content or material be posted on any of KWLaw's websites in the future.

WHEREAS, Grossman understands and acknowledges that KWLaw is not responsible for fact checking or reviewing articles before the articles are published, and that this is Grossman's sole responsibility; however, Grossman understands that articles must be preapproved to ensure that there are no conflicts regarding the content.

AGREEMENT

Grossman understands and agrees that the above recitals are true and correct and are hereby incorporated by reference as being binding provisions of this Agreement. In addition to the foregoing, Grossman further warrants and represents as follows:

1. KWLaw has policies and procedures in place to ensure that its reputation is upheld and that any content is written with professionalism.
2. Grossman understands and agrees that these policies and procedures include, but are not limited to, the requirement that any content or posts on any KWLaw site, social media account, blog, or KWLaw property (collectively "KWLaw Site") be approved by KWLaw.
3. Grossman understands and agrees that no content or posts are to be made to any KWLaw Site until approved by KWLaw, and that any posting without approval is unauthorized.
4. Grossman understands and agrees that before any undertaking any project, content writing, or posting, that a conflict check must be performed with KWLaw to ensure that no article would conflict with any current or former Client of KWLaw.
5. Grossman understands and agrees that the conflict check policy and the requirement that KWLaw approve all content or posts before they are made is critical to the viability of the firm and its reputation.
6. Grossman understands and agrees that by any posting of content without prior approval by KWLaw would be a violation of the policies and procedures in place.
7. Grossman understands and agrees that on June 11, 2015 content was published without prior authorization of KWLaw in direct violation of the policies and procedures in place.
8. Grossman understands and agrees that Grossman will abide by all policies and procedures set forth by KWLaw now and in the future.
9. Grossman understands and agrees that the failure to abide by these policies and procedures set forth by KWLaw may be grounds for immediate termination of the relationship between the parties with cause.

BW (B) Grossman has carefully read this Agreement in its entirety;

BW (C) Grossman agrees to all of the terms and conditions set forth herein.
